Give way sign at Hartlaw needs replaced as it was broken by a wagon. Letter to be sent to Cumbria Highways.

Jubilee - it was questioned whether the Parish would be doing anything to celebrate the Jubilee. There is a lot going on in Silloth. The Parish does not have a focal point and there are very few children in the Parish now.

Grass verges are getting chewed up and it was questioned whether they can be kept tidier. Wagons are getting bigger and chewing up the verges. A 7.5 ton weight restriction is to be put on Causewayhead Lane but nothing has been done to implement it yet.

Dog fouling is a problem, along the road leading up from the entrance to Tanglewood. A dog bin could not be put up because it is not within the speed limit. Letter to Allerdale Borough Council to ask for signs to be put up.

It has been noticed that a few market stall holders have started camping on the Airfield overnight on the days running up to the Sunday market. The Parish Council are concerned that it will set a precedent and more people will start camping overnight. John to speak to Billy Slater on Sunday and to ask for his contact details for inclusion in the Parish plan, so that any complaints can go to him direct.
